### SECRETARY'S REPORT:

- Minutes from the November meeting were read.
- Marcia Bogash motioned to accept the September Minutes as read and Bill Skinner seconded the motion. The Minutes were passed as written.

### TREASURER'S REPORT:

- The Town will soon be ready to start their budget for the next fiscal year. Some suggestions were made for Budget possibilities such as a storage shed and a 0 turn mower as well as the previous budget items that have been allotted to the Board.
- Eagle Scout Sam Peregoy has requested the use of the field for his Eagle Scout Presentation, which he wishes to hold on April 2, 2006. The Board agreed.
- Sharon brought up condensing our present Mission Statement. We chose to use the list and not detail each item, especially for grants.
- Recycling For Education is now going on at the center. Three dollars will be earned for every eligible used ink cartridge the center receives and turns in for recycling.
